**CONSENTING TO THE APPOINTMENT OF JON YEARLY TO THE POSITION OF
CHIEF OF TECHNOLOGY & ADMINISTRATIVE SERVICES**

1 **WHEREAS**, pursuant to 9 *Del. C.* § 1120(b), the County Executive, upon the
2 advice and the consent of the County Council, shall appoint a Chief of Technology &
3 Administrative Services, who shall serve at the pleasure of the County Executive; and

5 **WHEREAS**, the County Executive has nominated Jon Yearly to serve as the Chief
6 of Technology & Administrative Services for New Castle County; and

8 **WHEREAS**, Mr. Yearly brings over 25 years of extensive experience in
9 government and technology, including his tenure as Acting Chief of Technology &
10 Administrative Services, where he has successfully overseen strategic planning,
11 budgeting, and all aspects of information technology and administrative services
12 operations; and

14 **WHEREAS**, Mr. Yearly has previously served New Castle County as Deputy Chief
15 of Technology, IS Manager, and Senior Network Engineer, where he has been
16 instrumental in modernizing and securing New Castle County's information systems; and

18 **WHEREAS**, New Castle County Council has given due consideration to the
19 qualifications and professional accomplishments of Mr. Yearly and finds him well suited
20 to serve as the Chief of Technology & Administrative Services.

23 Castle County that County Council hereby consents to the appointment of Jon Yearly as
24 the Chief of Technology & Administrative Services for New Castle County.
